USTRANSCOM Global Bulk Fuel Management & Delivery (GBFMD)



D&G provides mission planning, risk analysis, and strategic planning support to USTRANSCOM. Through this contract, D&G supports USTRANSCOM, Defense Logistics Agency (DLA), Office of the Secretary of Defense (OSD), Services, and Combatant Commands. D&G’s analysis, strategy and operational support impacts over 2 million servicemembers and weapon systems across CONUS and OCONUS.

USCG Joint Requirements Integration and Management System (JRIMS)



D&G provides capability and requirements analysis to the USCG Assistant Commandant for Capabilities (CG-7). D&G supports CG-7 to identify, analyze, and assess mission needs for eleven USCG missions. We assess capabilities to document gaps, assess risks and impacts, identify material and non-material solutions, and support prioritization for all USCG Level I/II Surface, Air and C4ISR programs.
